



## STUDENT GROUP REPRESENTATION SUBSIDY APPLICATION

Pimlico State High School Parents & Citizens Association, at its discretion, offers financial support to GROUPS of students (**10 or more**) who participate at a state, national and international level in Queensland Department of Education sanctioned events. Events may be considered upon written request to the Association. This scheme is designed to recognise and support a group of students' achievements.

To qualify for support, groups must meet the following criteria:

1. The group must consist of ten or more students.
2. The group must have participated in events sanctioned by the Queensland Department of Education. Their representation must have been reached through their initial involvement at the school level.
3. The event must be further than 300km from Townsville.
4. This application form must be completed by the Head of Department Teacher and signed by the Executive Principal, verifying that the students are participating in a school-based activity.
5. The subsidy scheme excludes Travel/Study tours.
6. Applications can be made to the P&C before the event.

***The subsidy amount awarded to the group will be determined on a case by case basis at the discretion of the P&C and voted on for approval by P&C Members at a General Meeting.***

Applications will not be accepted if the group received full financial support for the trip from a 3rd party/sponsor. This financial subsidy is to be paid to the school and not individual students.

*There is no limit on the number of representative events that a group can apply for each year (one application per event).*
